The normal course purchase exemption is available as C\&F's purchase of 10,000 Common Shares (together with other purchases by C\&F, and the other shareholders with which C\&F acts in concert, in the preceding 12 months) did not exceed $5 \%$ of the outstanding Common Shares of Economic; there is an established market for the Common Shares; and, the value of the consideration paid for the Common Shares will not exceed the market price, plus reasonable brokerage fees or commissions actually paid.
